Many thanks to our immediate past-President, Martin Schechter who has been instrumental in recruiting stakeholders for our current assessment on Health System Transformation to Meet the Challenge of Chronic Diseases (see page 2). He has also established important relationships with both the Royal Society of Canada and the Canadian Academy of Engineering to plan future collaborative assessments. Over the next few years, it is the intent of all three Academies to participate in providing expert, unbiased advice on issues that are highly relevant to Canadians.

## **Update on Assessments**

On behalf of CAHS, I extend a most sincere thanks to the outgoing chair of the Standing Committee on Assessments, Andreas Laupacis, as well as to the Committee members who have volunteered many hours of their time providing outstanding recommendations to the Board. This Committee is responsible for reviewing all of the assessment topics that come forward and to help formulate the most appropriate questions to be addressed through formal review by the assessment panels. They also recommend to the CAHS Board, the appointment of the chair and panel members for the assessment. During the assessment, the Committee appoints a Monitor to review the process that must adhere to the procedures set out by the CAHS, and then to recruit official external reviewers that provide feedback to the Board on the draft report. We now welcome John Cairns, the new chair of the Committee on Assessments who has been working very diligently with the Committee members these past few months on the a number of new assessment initiatives.

Many thanks to Louise Nasmith and Penny Ballem, the co-chairs of the major assessment now in progress—Health System Transformation to Meet the Challenge of Chronic Disease. The key question is – What will it take to improve outcomes for patients with chronic disease in Canada? This expert panel will create a strategy to improve health outcomes for patients with chronic disease through re-orientation of Canadian health services and better utilization of system resources from policy to point-of-care within the next five years. The blue-ribbon panel has been hard at work with much progress to date. They are aiming for completion of the report for review by the CAHS Board in time for official launch of the report in September 2010 at our annual general meeting.

An assessment related to Global Health has emerged under the leadership of Peter Singer and we expect the launch of this project early in the new year. Congratulations Peter for your leadership and commitment to this projects.

Please note that CAHS Board members who assume the role of chair of an assessment, will step off the Board for the duration of assessment. Assessment panel members may stay on the CAHS Board but are not involved in discussion or voting about decisions relevant to their assessment. The Chair of the Committee on Assessments is now invited to join the CAHS Board, ex officio.

# Re-cap – Annual General Meeting 2009

In September 2009, the CAHS hosted its 4th Annual General Meeting in Ottawa with over 100 members in attendance. We inducted and warmly welcomed 28 new fellows (see left side bar) along with the 2009 Distinguished Fellow – the Honourable Michael Kirby. For those of you who attended the induction ceremony, you will undoubtedly agree that our members are truly remarkable individuals who represent the most accomplished and committed health and biomedical science academics in Canada. Michael Kirby, himself a change agent for mental health care, challenged all of us to assume responsibility for critically assessing the health care needs of Canadians and contributing to effective system transformation.

The Global Health theme of the meeting, led by Peter Singer, focused on the question of Canada's Strategic Role in Global Health. Peter is the Foreign Secretary for the CAHS and organized a spectacular group of international experts to address this question. Elizabeth Dowdeswell, who also chairs the Scientific Assessment Committee of the Council of Canadian Academies, chaired the Symposium panel reflecting on the Historical Perspectives of Canada's Role in Global Health and the session addressing the specific question – What can the Government of Canada Contribute to Canada's Strategic Role in Global Health? Prahbat Jha presented the findings of the Institute of Medicine (IOM) assessment report entitled The US Commitment to Global Health. Prahbat was the only Canadian who served on this IOM assessment committee and highlighted the recommendations to: 1) speak out about the importance of global health; 2) to double the US financial investment in global health initiatives; 3) to focus more research efforts on solving major global health problems; and, 4) build better relationships with developing world institutions for sustainable partnerships. To conclude, Bartha Knoppers chaired a report back session following small group discussions on – What Can Universities, Civil Society and Industry Contribute to Canada's Strategic Role in Global Health?
