PRESIDENT'S MESSAGE

Dear Fellows,

I hope you had a joyful holiday season and 2017 brings health and happiness to you and your families.

It is once again time to nominate individuals for Fellowship. We rely on our Fellows to bring forward names of outstanding people across the health disciplines who deserve recognition and who will contribute to the mission of CAHS. **Please take the time to nominate a colleague. Please also respond to the request below from the Governance and**

Nominations Committee for nominations for Board appointments and 2017 Award recipients.

We are well into planning our Forum 2017 on Antimicrobial Resistance. Forum co-chairs, **John Conly** and **John Prescott**, have developed an exciting program that bridges veterinary science and human health with speakers who will bring us up to date on topics from basic science to public health within Canada and worldwide. Plan to attend the Forum and AGM in Ottawa on September 14 and 15 and take the opportunity to also celebrate Canada's 150th birthday!

Meanwhile your Board continues to work on your behalf to raise the profile of the Academy within Canada and internationally, to work effectively with partner organizations, including the Council of Canadian Academies, and to raise the funds necessary to fulfil our mission. We are excited about forthcoming partnered work with the CCA and our sister academies around *Medical Assistance in Dying read more*. Three Panels will be created to deal with advanced directives, decision-making by minors and individuals with mental illness. We will be recommending Fellows whom we know have expertise for membership on these Panels and encourage you to let us know if you have particular interest in being considered. We continue to seek support for our proposed Assessment on *Dementia* and continue to work on follow up to the 2016 Forum on *Indigenous Health*.

The Standing Committee on Assessments and the Board are actively engaged in revising our process for developing Assessments, with the aim of engaging sponsors early in the development of a relevant question and having the necessary funds committed at the outset. We anticipate using Round Tables to bring together stakeholders and ensure our major activity as an Academy is better aligned. In terms of our *Assessment Report on Team Science*, we did encounter some delays but are now back on track and a Spring 2017 publication is highly anticipated.

As I reported in September, we have become more engaged internationally with active involvement in the organization of the 2016 InterAcademy Panel (IAP) for Health conference in Beijing. Jeff Turnbull, who co-led the assessment on *Optimizing Healthcare for Canadians*, gave a keynote address at the IAP

meeting in Beijing. CAHS is also leading the development of an IAP Statement on Dementia. We are grateful to **Howard Chertkow** and the CCNA Research Committee who revised our Statement which has now gone to an InterAcademy Committee for further work to ensure it will be useful internationally. It will then go for ratification to IAP member Academies.

We continue to engage in meaningful work to increase the profile of the Academy. A pilot project was launched in Toronto in November, led by **Linda Rabeneck**, with the goal of producing at least two Op Eds in 2017; We collaborated with the CCA, the RSC and the CAE in the November 2016 pre-Workshop of the Centre for Science Policy Conference on evidence-based decision-making; and **Keith Sharkey** did an excellent job of representing the CAHS at a recent national meeting organized by the Canadian Centre for Substance Abuse to derive a National Research Agenda on the Health Impacts of Non-Medical Cannabis. CAHS was invited by the Peter Wall Institute for Advanced Studies at UBC to submit a chapter on major issues facing Canadians for a book to be released to celebrate Canada's 150th anniversary. In response, a writing committee consisting of **Christian Naus**, **Catharine Whiteside**, **Carol Herbert**, **Louise Nasmith**, **Paul Allison**, **Siobhan Nelson**, and **Jean Gray** synthesized a chapter based on the CAHS assessment reports on Chronic Diseases, Oral Health of Vulnerable Populations, and Scopes of Practice. An article on Dementia, authored by **Howard Feldman** and **Carole Estabrooks**, Co-Chairs of the 2015 Forum, is In Press at the Canadian Journal of Public Health; and I submitted an invited Open Letter entitled *"Nothing About Us Without Us": Taking Action on Indigenous Health*, for a series by Longwoods.

On May 12, the CAHS will co-sponsor an Invitational Symposium in Toronto to celebrate the 80th Anniversary of the Associated Medical Services (AMS) and the 50th Anniversary of Canadian Medicare. The event, entitled *Canadian Medicare 2017: Historical Reflections, Future Directions* will be co-chaired by **Greg Marchildon** (CAHS Fellow) and Colleen Flood, former Scientific Director of the CIHR Institute on Health Services and Health Policy Research. Several Fellows were involved in planning this event, including your President. The submitted papers will be published following the meeting. Celebrations will begin a day earlier – on May 11 – with a public presentation on *The Past and Future of Canadian Medicare* at 4:00 pm at MaRS, facilitated by **David Naylor**.

The CAHS operates with a part-time paid staff member, Allison Hardisty, who provides incredible support and we rely heavily on the volunteer time of our Board and Committee members. However, we need more resources to enable us to sustain and expand our activities. We continue to work with a communications consultant on a new brand and profile for the organization, including an updated website to serve our Fellows better. We anticipate launching a significant fundraising campaign in the coming months and hope you will consider the CAHS when planning your personal philanthropy this year.

I thank you for your ongoing engagement and support as we honour outstanding Canadian health scientists by electing them to Fellowship and as we contribute our expertise to create a healthier Canada.

FELLOWSHIP COMMITTEE

The formal call for nominations was released in January. As primary nominators, CAHS Fellows provide a letter of nomination that introduces the nominee and co-nominators and they have responsibility for coordinating the entire nomination package. Support materials have been developed to assist you in this task and may be accessed through our website at <u>http://cahs-acss.ca/nominations/</u> The deadline for nominations is <u>Friday, March 10, 2017</u>. 2247 Fax 613-567-5060 info@cahs-acss.ca Nominations will be adjudicated by the Fellowship Committee in April. Nominees will be advised of the outcome early in May, but the information is embargoed until Induction in September. The 2017 ceremony will be held on Thursday evening, September 14, 2017 at the Chateau Laurier Hotel in Ottawa.

Because a large number of outstanding candidates are nominated each year, it is inevitable that some excellent people are not successful in their first year. Nominations remain active for three years and annual solicitations are made to primary nominators so that they can update the original nomination package during the current nomination period. An update may range from the replacement of one piece of the original submission (the CV for example) to an entirely new nomination package.

Call for Volunteers! The Fellowship Committee reviews nominations for Fellowship in the CAHS, assigns ratings and provides the list to the Board for decision. Membership is not onerous, the work is rewarding and orientation is provided. Participation in the annual web-based review meeting is however mandatory: the 2017 review meeting will be held on <u>April 22nd</u>. CALL FOR NOMINATIONS – PRESIDENT ELECT The CAHS will be choosing a <u>PRESIDENT-ELECT</u> to be appointed in **September 2017**. The choice of President-elect is of critical importance to our Academy. This individual serves in a six year commitment, with two years as President-elect, two years as President and two years as past-President. These are all very much active roles. As well as being a member of the CAHS Board and Board Executive, the President-elect has a variety of assigned duties and the role of President carries substantial responsibilities as the overall leader of the Academy. We are working hard to develop the profile of CAHS as the "go to" organization for governments and NGO's in regard to health policy development. Our activities in government relations and development (fund raising) are intensifying. The past-President continues to be a member of the Board and of the Executive and has specific responsibilities as Chair of two key Standing Committees.

This leadership role with the CAHS offers the individual the opportunity to lead the activities of over 600 highly accomplished Fellows. There are significant satisfactions from engagement in a Board of Directors made up of outstanding leaders in academic health sciences and with many organizations and leaders of academic health sciences nationally and internationally. As President-elect and then as President, the CAHS leader sits on the Board of the Council of Canadian Academies (CCA), along with leaders of the Royal Society of Canada and the Canadian Academy of Engineering. The CCA conducts independent, authoritative, and evidence-based expert assessments that inform public policy development in Canada in response to requests primarily from the federal government, but also from other levels of government, NGOs and industry. Whereas CAHS assessments focus on health, CCA assessments occur across the spectrum of the sciences and the arts.

STANDING COMMITTEE ON DEVELOPMENT & STRATEGIC COMMUNICATIONS

The CAHS Board has approved a new plan, submitted by the Committee, for strategic communications with external stakeholders. REGIONAL MEETING UPDATES

Regional meetings provide an opportunity to be connected to other Fellows and to the work of the Academy between annual general meetings. The Board is happy to note that there is now a small budget available (up to \$200) to help with refreshments as needed. Inviting the participation of graduate students, post-docs and/or younger faculty members will serve to increase their exposure to some of the top scientists in the health sciences in their region. Our regional networks function less as formal chapters of the Academy but rather informal forums intended to rally Fellows together, building relationships, incubating ideas and crafting assessment and forum topics. Regional networks also play an increasingly important role in helping to promote and disseminate the work of the Academy in the provinces and identifying worthy candidates for nomination of Fellowship.

SASKATCHEWAN

Jay Kalra and Kishor Wasan hosted 25 Saskatchewan CAHS Fellows and health sciences leaders - including VP Research, KAREN CHAD, and CEO of the Saskatchewan Health Research Foundation, HEATHER MAGITIOUX - from around the province at the First Annual Saskatchewan Canadian Academy of Health Sciences Mini Symposium on November 7th in Saskatoon. CAHS President, **Carol Herbert**, was our keynote speaker and we formally inducted **Debra Morgan** as a new Fellow of the Academy as she was not able to attend the event in Montreal.

ASSESSMENT NEWS

The Academic Recognition of Team Science assessment should have gone to peer review in Fall 2016 but at the October face-to-face meeting of the panel it was recognized that there was still work to be done. Accordingly, another face-to-face meeting was deemed necessary in January prior to the report being sent for peer review. The sponsors have all been contacted and will receive a pre-translation pdf version of the report by late March with a public release scheduled for late April, following translation and printing.

The Standing Committee on Assessments (SCA) is very grateful to **Howard Bergman** who has been a major resource as we develop an assessment arising out of the 2015 forum on Dementia. A prospectus is now circulating and the Committee on Development & Strategic Communications, under the leadership of **Catharine Whiteside**, is assisting with fundraising. This report will be a collaborative effort of CAHS and the CCA.

A proposal for an assessment on medical use of marijuana received considerable discussion in Fall 2016 but with the assistance of **Keith Sharkey**, who represents CAHS at the Canadian Centre on Substance Abuse and who has provided the SCA with an overview of the several reports currently being generated on this topic, the SCA decided not to pursue this further. The originator of the proposal has been informed and recognizes this is a rapidly developing area. Preliminary discussion has begun to fashion an assessment on Indigenous health arising from the September 2016 Forum.

The SCA has drafted a set of recommendations regarding the CAHS approach to, and the nature of, assessments which was reviewed at the Board meeting in September. Revisions were requested and the recommendations will be resubmitted in the near future.
