CALL FOR FELLOWSHIP NOMINATIONS

The annual call for Fellowship nominations will be released early in January. As primary nominators, CAHS Fellows provide a letter of nomination that introduces the nominee and co-nominators and they have responsibility for co-ordinating the entire nomination package. The deadline for nominations is <u>Friday</u>, <u>March 9</u>, <u>2018</u> and support materials are available on the website at http://www.cahs-acss.ca/nomine ations/

CALL FOR NOMINATIONS: FOREIGN SECRETARY

The Academy is seeking applications from energetic and enthusiastic Fellows interested in the role of Foreign Secretary in 2018. Specific responsibilities include:

- 1. Guide and have responsibility for the international activities of CAHS;
- 2. Build and maintain partnerships with Academies of Medicine/Health elsewhere in the world;
- 3. Develop relationships with global and regional networks of Academies such as IAMP and IAP;
- 4. Assist in identifying outstanding health scientists from abroad to be nominated as international members of the CAHS, especially from countries under-represented in the Academy;
- 5. Identify leading Canadian global health scientists from any discipline for possible appointment to CAHS through its usual processes.

This appointment has a renewable term of three years. The Foreign Secretary is an ex officio member of the CAHS Board, which meets by conference call approximately every two months for two hours, and face-to-face twice each year (once at the Annual Meeting in September and once sometime between January and June).
