### **CALL FOR NOMINATIONS**

The formal call for nominations was released in January. As primary nominators, CAHS Fellows provide a letter of nomination that introduces the nominee and co-nominators and they have responsibility for co-ordinating the entire nomination package. Nominations will be adjudicated by the Fellowship Committee in April 2018. New Fellows will be inducted into the Academy at the dinner ceremony on Thursday, September 13, 2018 during the Annual General Meeting at the Marriott Pinnacle Downtown Hotel, Vancouver.

Because a large number of outstanding candidates are nominated each year, it is inevitable that some excellent people are not successful in their first year. Nominations remain active for three years and annual solicitations are made to primary nominators so that they can update the original nomination package during the current nomination period. An update may range from the replacement of one piece of the original submission (the CV for example) to an entirely new nomination package.

*Call for Volunteers!* The Fellowship Committee reviews nominations for Fellowship in the CAHS, assigns ratings and provides the list to the Board for decision. Membership is not onerous, the work is rewarding and orientation is provided. Participation in the annual web-based review meeting is however mandatory: the 2018 review meeting will be held on <u>April 23rd</u>. #### **REGIONAL MEETING UPDATES**

#### **SASKATCHEWAN**



Jay Kalra and Kishor Wasan hosted the 2<sup>nd</sup> Annual Saskatchewan Canadian Academy of Health Sciences Mini Symposium on November 8<sup>th</sup>, 2017 in Saskatoon to about 20-25 Fellows. We were honoured to have **Catharine Whiteside**, Professor Emerita and Former Dean of Medicine at the University of Toronto and the Executive Director of the SPOR Network in Diabetes and its Related Complications, join us as keynote speaker.

On behalf of the Academy, we formally Inducted structural biologist **Miroslaw Cygler** and respirologist **Darcy Marciniuk,** both at the College of Medicine, as new CAHS Fellows as they were unable to attend the formal Induction Ceremony in Ottawa.

#### **NOVA SCOTIA**



The Nova Scotia Health Research Foundation sponsored a discussion led by Dr. Stephen Bornstein (pictured left) on the recent CAHS report, *"Academic Recognition of Team Science: How to Optimize the Canadian Academic System"* of which he was an author. Dr. Jean Gray, provided background information on the assessment. Dr. Bornstein is a professor of Community Health and Humanities and Professor of Political Science at Memorial University as well as Director of the Newfoundland and Labrador Centre for Applied Health Research. He presented to an audience of senior academic administrators from Nova Scotia universities as well as CAHS Fellows.

On Thursday, December 7th, 2017, **Jean Gray** presented her 2017 Armstrong Lecture again in Halifax at the Dalhousie College of Pharmacy. The IMPART Seminar, entitled *The Promise and Perils of Contemporary Therapeutics* was attended by CAHS Fellows and researchers from the Dalhousie Faculties of Law, Medicine and Health as well as from the Nova Scotia Health Authority.

# **ASSESSMENT NEWS**

CAHS is in the negotiation stages to initiate a new assessment, but one with a twist. At the request of the Public Health Agency of Canada (PHAC), a rapid assessment on dementia with an abbreviated time frame is being planned (all subject to final agreement). All previous CAHS assessments have taken 18 to 24 months. The question(s) for this report arise directly from legislation to create a national strategy on dementia. CAHS has agreed to create a small panel and, because CCA staff who previously provided project management for our last assessment are fully engaged this year, an external consultant (Sonya Kupka) - who has previously assisted CAHS with an assessment - has been hired for this project.

The panel will be chaired by **Dr. Howard Bergman** (FCAHS), Chair of Family Medicine and Professor of Family Medicine, Medicine, Geriatrics and Oncology at McGill. Five other members have also agreed to join the panel.

The panel will hold three face-to-face meetings with an interim report available for PHAC in July and a final peer-reviewed report by October. The process undertaken during this abbreviated time frame will be carefully evaluated to determine whether CAHS can offer rapid assessments to other government departments in the future. Dr. Bergman has been invaluable in assisting the SCA in determining the question to be assessed and in establishing the panel in a very short time. Eleanor Fast, our new Executive Director, has been exceptional in working with the SCA, PHAC and Dr. Bergman in expeditiously moving this project forward.


